- 第一條 本學程依據本校「組織規程」第六十條及本校「教師評審委員會設置辦法」 第二條規定,設置本學程「教育與人類發展研究全英語學位學程教師評審委員會」 以下簡稱本會。
- 1. The "Teacher Evaluation Committee of the International Graduate Program of Education and Human Development" (hereafter "the Committee") is established in accordance with Article 60 of the university's "Articles of Association" and Article 2 of the university's "Regulations Regarding the Establishment of Teacher Evaluation Committee."
 - 第二條 本會由本學程主任召集,並擔任會議主席;本會委員由本學程主任邀請本 校專任助理教授以上之教師代表4至7人組成之。
- 2. The program director shall convene and preside over the Committee, and shall invite four to seven teachers with the rank of full-time assistant professor or above to serve as members.

第三條 本會之職掌如下:

- 1. 教師之聘任、聘期、升等、停聘、解聘、不續聘、延長服務、借調、 出國講 學、研究、進修、教授休假研究、年資加薪、教師資遣原因之認定等事項之審 議。
- 2. 其他依法令應經本會審議之事項。

前項審議之事項,應先經本學程會議決議後,提交本會審議。委員不得參與高於本身職等教師升等之聘任、升等、延長服務等教師資格審查案審議。

- 3. Responsibilities of the Committee members are as follows:
- A. Matters regarding the employment, duration of employment, promotion, suspension, dismissal, non-renewal, service extension, temporary transfer, conducting lectures abroad, studies, education, research leaves, and pay raise of teachers as well as confirmation of the causes for teacher severance.
- B. Matters regarding other regulations that must be considered by the Committee. The previous consideration item shall be decided by the university's Program Affairs Meeting before being submitted to this Committee for consideration. Committee members shall not participate in employment, promotion, service extension consideration matters for teachers whose rank is higher than themselves.
- 第四條 本會不定期舉行會議,開會時應有委員三分之二以上(含)之出席,本辦法第 三條所訂定審議之事項,需經出席委員三分之二以上(含)之贊同,始得通過。本 會開會時,委員應親自出席,不得由他人代理。
- 4. This Committee shall hold meetings occasionally. Two thirds or more of the members shall attend in order for the meeting to convene. Matters specified in Article 3 of this Regulation shall be approved by two thirds or more of the attending members in order to be adopted. Members shall attend Committee meetings in person, and cannot attend through a representative.
- 第五條 本會開會時,得邀請有關人員列席說明。
- 5. Relevant persons may be invited to the meeting to provide instructions.
- 第六條 本會委員對於評審案件涉及本人、配偶、三親等內之血親、姻親或有個人 利害關係者,應自行迴避,不得參與評審。有具體事實足認本會委員對 於評審案件有偏頗之虞者,申請人得向本會申請該委員迴避,並應舉其 原因事實。委員未自行迴避者,召集人得經本會決議,請該委員迴避。 委員中有前三項應行迴避之情事者,不計入出席委員人數。學程教評會 得比照第四條規定辦理。
- 6. If the evaluation case involves a Committee member's own person, spouse, third-degree relatives, relatives by marriage, or if a Committee member has personal stakes in the matter, the said member shall voluntarily abstain from the meeting. Should any person have sufficient factual evidence to prove partiality by certain Committee members, the said person shall submit an application to this Committee and provide supporting facts to recuse the member. If the said Committee member fails to abstain voluntarily, the convener shall invite the member to abstain through Committee resolution. Committee

members who meet the criteria specified in this Article shall not be included in the number of members present. The Teacher Evaluation Committee on Program Affairs shall hold meetings in accordance with the provisions provided in Article 4.

第七條 其他與本學程有關,但非為本辦法第三條所列之事項,悉由本學程會議議決 之。

7. Other related matters not specified by Article 3 of this Regulation shall be resolved through the Program Affairs Meeting.

第八條 本辦法未盡事宜,悉依本校相關規定辦理。

8. Matters not specified by this Regulation shall be handled in accordance with the relevant regulations of the school.

第九條 本辦法經學程會議通過,送請院教師評審委員會審議通過,送請校長核定後 實施;修正時亦同。

9. This Regulation and its amendments shall be approved by a Program Affairs Meeting, a Collegiate Teacher Evaluation Committee, and the president prior to implementation.
