## Guidelines for the Five-Year Bachelor's and Master's

### Degree System

- Article 1. The Guidelines were established to encourage outstanding undergraduates to stay and study for their Master's degree at the university for the sake of continuous learning and a shortened study period.
- Article 2. Students admitted under the Guidelines are qualified as candidates for a Bachelor's degree and as pre-graduates for the Master's program (hereafter referred to as "pre-graduates").
- Article 3. An undergraduate student who demonstrates academic excellence after enrollment may apply to the Master's program of their preferred department (institute) for pre-graduate status in the 2nd semester of their third year at the time specified in the calendar. The approved candidate is qualified as a pre-graduate; the selection criteria are defined by each department (institute) and submitted to the Office of Academic Affairs for reference.  
In addition to announcing the list of qualified pre-graduates, each department (institute) should also submit the list to the Office of Academic Affairs for reference.
- Article 4. Students qualified as pre-graduates must obtain their Bachelor's degree within the specified study period (not including extended study periods) and participate in the Master's program selection or examination in the academic year of their graduation. Once accepted, they are formally qualified as a graduate student in a Master's program at the university.
- Article 5. Once a pre-graduate is accepted by a Master's program at the university, they may apply for a transfer of credits from the additional graduate courses they completed

as an undergraduate; if the credits from the graduate courses they took had already been counted towards their undergraduate graduation requirements then they may not be transferred to the credits of the Master's program.

Article 6. Pre-graduates accepted by a Master's program should count towards the admission quota for the academic year of that program.

Article 7. Any matters not covered in the Guidelines shall be handled in accordance with the Academic Regulations and related policies.

Article 8. The Guidelines were approved by the Academic Affairs Council and sanctioned by the University President prior to implementation. Modifications shall follow the same procedure.

# 國立中山大學五學年學、碩士學位辦法

第一條 為鼓勵本校學士班優秀學生繼續留在本校就讀相關系所碩士班，並期達到連續學習及縮短修業年限之目的，特訂定本辦法。

第二條 本辦法錄取之學生兼具學士學位候選人及碩士班預備研究生（以下簡稱預研究生）資格。

第三條 學士班學生入學後，表現優異者，得於三年級下學期，依行事曆規定時間，向擬就讀系所碩士班提出預研究生之申請，經各系所甄選通過者，取得預研究生資格；甄選辦法由各系所自訂，並送教務會議核備。

各系所除應公告甄選通過之預研究生名單外，並須將名單送教務處備查。

第四條 獲得預研究生資格之學生，必須於規定修業年限內（不含延長修業）取得學士學位，並於畢業當學年度參加預修之碩士班甄試或考試，經錄取後，始正式取得本校碩士班研究生資格。

第五條 預研究生錄取本校碩士班入學後，其在學士班期間所選修之研究所課程，可申請抵免碩士班研究生應修學分數；但所選修之研究所課程若已計入學士班畢業學分數內，則不得再申請抵免碩士班學分數。

第六條 預研究生錄取本校各系所碩士班之名額，應包含於當學年度該系所碩士班之招生名額內。

第七條 本辦法如有未盡事宜，悉依本校學則及相關規定辦理。

第八條 本辦法經教務會議通過，陳請校長核定後實施，修正時亦同。
