一、為辦理教育研究所(以下簡稱本所)之專、兼任教師聘任案,依據本校「教師評審委員會設置辦法」、「教師及研究人員聘任規則」、「兼任教師聘任 資格審查要點」及「本所教師評審委員會(以下簡稱所教評會)設置辦法」之 規定,訂定本要點。

Article 1 The present Regulations are formulated in accordance with NSYSU Regulations of Faculty Evaluation Committee, Regulations of Faculty and Researcher Appointment, Regulations of Adjunct Faculty Appointment Review, and IOE's Faculty Evaluation Committee for the purpose of appointing full-time and adjunct faculty.

二、本所教師之聘任等相關事宜,除法令另有規定外,悉依本聘任要點辦理。

Article 2 Faculty appointment in IOE is subject to the present Regulations and exceptions will be applied if other relevant regulations are present.

- 三、本所教師之聘任資格應符合本校「教師及研究人員聘任規則」第三條之規定, 新進教師之聘任並應依本校「新進教師聘任審查要點」辦理。
- **Article 3** Candidates applying for IOE's faculty position shall meet the criteria of the third article in NSYSU Regulations of Faculty and Researcher Appointment.
- 四、新聘專任教師之聘任程序<u>,應符合本校「教師及研究人員聘任規則」之規定,</u> 經本所教師評審委員會初審通過,提送院教師評審委員會辦理複審。複審通 過後,再提送校教師評審委員會辦理決審。

新聘教師除符合本校「教師及研究人員聘任規則」規定免辦理著作外審者之外,均應辦理前一職級以後之專門著作(含學位論文)或技術報告外審,惟 提送件數至多10件。擬聘教師應自行擇一為代表作,其餘列為參考作,其屬 系列之相關研究者,得合併為代表作。

前項著作外審程序依本校「教師及研究人員聘任規則」之規定辦理。

Article 4 New faculty appointment procedure shall be subject to NSYSU Regulations of Faculty and Researcher Appointment. Application will be sent to the second appointment review to be held in College of Social Sciences' Faculty Evaluation Committee if successful in the first appointment review in IOE Faculty Evaluation. If successful in the second review, the final appointment review will be held in NSYSU's Faculty Evaluation Committee.

The candidate may not send his or her works for external review if he or she meets the criteria listed in NSYSU Regulations of Faculty and Researcher Appointment. For external review, the candidate shall present his or her work(s) (graduation thesis included) or technical report(s) which were published after the start date of his or her previous rank, in which one work shall be selected as a representative work and the rest reference works; and the works in a series may be combined as one representative work.

The process of external review mentioned above is subject to NSYSU Regulations of Faculty and Researcher Appointment.

五、本所新聘兼任教師之聘任程序,悉依本校「兼任教師聘任資格審查要點」之 規定辦理。

Article 5 The appointment process for adjunct faculty at IOE is subject to NSYSU Regulations of Adjunct Faculty Appointment Qualifications.

- 六、聘任案每案討論應徵教師一名。議決時,採無記名投票。
- **Article 6** Each appointment case shall hold only one candidate. Resolution shall be reached through anonymous voting.
- 七、<u>有關</u>教師之初聘、續聘、長期聘任<u>、解聘、停聘、</u>不續聘<u>及其他相關事項</u>, 以及本要點未盡事宜,<u>悉</u>依本校<u>「教師及研究人員聘任規則」及</u>相關規定辦 理。
- **Article 7** Matters unmentioned in the present Regulations, regarding new appointment, appointment extension, long-term appointment, appointment termination, appointment suspension, discontinued appointment, are subject to NSYSU Regulations of Faculty and Researcher Appointment and other relevant regulations.
- 八、本要點經所務會議通過,送請本院教師評審委員會審議通過,陳請校長核定 後實施;修正時亦同。
- **Article 8** The present Regulations and the amendments shall be approved by IOE Institute Affairs Meeting, College of Social Sciences' Faculty Evaluation Committee, and NSYSU President prior to implementation.
