- I. This set of guidelines for faculty evaluations of the Institute of Undersea Technology (hereinafter referred to as "the Institute") is issued in accordance with National Sun Yat-sen University's faculty evaluation regulations in order to improve teaching, research, as well as counselling and service qualities.
- II. Except for those full-time faculty members of the Institute who meet the conditions specified in "National Sun Yat-sen University Regulations of Faculty Evaluation" are exempt from being evaluated, all full-time faculty members shall be evaluated in accordance with the present guidelines. Faculty members who shall be evaluated but do not proved evaluation information will be regarded as "not approved."
- III. The proportions each evaluation indication accounts for in a faculty evaluation of the Institute are: 25% for teaching, 65% for research (performance), and 10% for counselling and service, with 100% being the total.
- IV. Scores of the Institute's faculty evaluation shall be processed in accordance with "Table of Faculty Evaluation Indicators" of the university.
- V. The evaluation results are "approved," "approved with conditions," and "not approved."
- VI. In addition to regulations of the present guidelines, matters related to the Institute's faculty evaluation, including assessment items, methods, standards and procedures, etc., shall be processed in accordance with "National Sun Yat-sen University Regulations for Faculty Evaluation" and its enforcement rules as well as relevant regulations of the College of Marine Sciences.
- VII. The present guidelines shall be implemented following approvals of institute general meetings, the College Faculty Evaluation Committee, and the University Faculty Evaluation Committee. The same procedure shall be carried out when amendments are to be made.
