

## National Sun Yat-sen University Foundation Act of Si Wan College

- Article 1 To develop and promote general and interdisciplinary education and cultivate cross-disciplinary talents, National Sun Yat-sen University (hereinafter NSYSU) established Si Wan College (hereinafter the College) following the university's acts.
- Article 2 The College consists of Center for Essential Education, Center for General Education, Center for Physical and Health Education, Centre for Service-learning Education and Program in Interdisciplinary Studies; each is responsible for research and development related to general education and interdisciplinary education.
- The College has a certain number of full-time, part-time faculty members, and administrative staffs to carry out teaching and relevant administrative duties. The College also recruits a certain number of full-time faculty members as 特約教師 (guest faculty) from various undergraduate and graduate departments. The guideline for recruiting guest faculty should be further regulated.
- Article 3 Duties of the College:
1. Research, discuss and promote the vision of general and interdisciplinary education.
  2. Plan, review, and offer courses concerning general and interdisciplinary education.
  3. Evaluate, inspect, refine and improve the courses of general and interdisciplinary education regularly.
  4. Promote the spirit of service-learning and general education at the university.
  5. Inspect, plan, and allocate budget.
  6. Manage other relevant affairs.
- Article 4 A full-time full professor shall be appointed the dean of the College by the president of NSYSU to supervise affairs at the College. An associate dean shall also be assigned to assist the dean. The candidate of the associate dean shall be nominated by the dean and approved by the president.

- Article 5 Each center and unit at Si Wan College is led by a chair or an executive officer. The candidate shall be nominated by the dean and approved by the president.
- Article 6 The committee of general and interdisciplinary education at NSYSU is responsible for planning major policies in relation to general and interdisciplinary education and its vision.
- Article 7 The College holds College Affair Meetings and organizes committees of Faculty Evaluation, Curriculum, as well as of other affairs to carry out relevant duties. The foundation act for each committee should be further regulated.
- Article 8 Matters not provided herein is subject to relevant regulations.
- Article 9 The Foundation Act and amendments are promulgated after being approved by the Academic Affairs Meeting.
