## National Sun Yat-sen University Institute of Economics Regulations for the Five-Year Bachelor's and Master's Degree Program

Approved at the 2<sup>nd</sup> Institute Meeting of the 1<sup>st</sup> Semester of AY2005 on December 13, 2005.

Amended and approved at the 8<sup>th</sup> Institute Meeting of AY2008 on May 19, 2009.

Amended and approved at the 131<sup>st</sup> Extraordinary Academic Meeting on March 19, 2012.

Amended and approved at the 1<sup>st</sup> Extraordinary Institute Meeting of AY2013 on November 19, 2013.

Amended and approved at the 132<sup>nd</sup> Academic Meeting on December 17, 2013.

These Regulations are established to encourage undergraduate students of National Sun Yat-sen University (NSYSU) with outstanding achievements to further their study at the NSYSU, ensure uninterrupted undergraduate-to-graduate study, and earn both the bachelor's and master's degrees in as little as five years.

- Article 1 All NSYSU undergraduate students with outstanding academic achievements and meeting the following requirements may apply for the "Guideline for the Five-Year Bachelor's and Master's System" after completing undergraduate study for five semesters.
- Article 2 There will only be three vacancies each academic year.
- Article 3 "All NSYSU Undergraduate Students" under these Regulations mean students enrolling on any bachelor's program offered by the NSYSU.
- Article 4 Applicants must submit the following data:
  - 1. An application form (with a statement of purpose (self-introduction/autobiography)).
  - 2. A transcript with ranks of the first five semesters in the undergraduate program.
  - 3. Two letters of recommendation from professors.
  - 4. Other documents that can support their research capacity.
- Article 5 After the approval of this Institute, the accepted student will be a bachelor candidate and a pre-graduate student (hereinafter called the "Pre-Graduate Student") at the same time.
- Article 6 After becoming a pre-graduate student, a student must complete the bachelor's program within the expected length of study and take the master's degree screening examination or entrance examination. A student must pass the examination before becoming an authentic graduate student of the master's program.
- Article 7 After becoming an authentic graduate student of the master's program, a student may apply for a credit transfer of the master's program courses completed during the undergraduate years. However, a student cannot apply for a transfer of the credits of master's program courses that have been included in the required credits for graduation of the bachelor's program.
- Article 8 Matters not provided for herein will be subject to the regulations and related rules of the Five-Year Bachelor's to Master's Degree Program.
- Article 9 These Regulations will be implemented after the approval at the Institute Meeting and Academic Meeting. The same shall apply to the amendments thereto.
