I. The number of students (students of industrial research programs, five-year BS-MS programs, recommendation examinations, and direct PhD programs) per supervisor in Master's and PhD programs shall not exceed 12 students within two years.

Regulations on Supervisions for Master's Students

- 1. In the first round (application ends September 1 each year), each faculty member (including directors) may accept 5 applicants (five-year BS-MS students not included) or 6 (including five-year BS-MS students).
- 2. First-year students shall retrieve the Form of Supervisors of First-Year Students from the department office, or download a copy from the university website. The form shall be completed and signed by the supervisor, and submitted to the department office prior to September 1.
- 3. The number of students per supervisor in the second round (prior to September 15) is calculated based on the average number of students that failed to find supervisors in the first round (prior to September 1) divided by the number of faculty members in the department. If the average is less than 1, a co-supervision of 1 student is allowed when the total number of assigned students of 2 (or more) faculty members is greater than 1 and less than 2, and so forth.
- 4. Students that fail to find supervisors following the third round (after September 15) shall be appointed an available professor by the director.
- 5. A full-time joint-appointed professor that also teaches at least 1 undergraduate course may independently supervise 1 graduate student.
- 6. Any particular circumstances must be approved by half of the total attendees at department meetings.

Regulations on Supervision for Doctoral Students

- 1. In the first round (prior to October 1), each faculty member may accept one new doctoral student (direct advancement, direct entry, and in-service doctoral students not included).
- 2. For students that fail to find supervisors in the first round (after October 1), all faculty members (faculty members already supervising doctoral student of direct advancements not included) may each accept an extra doctoral students.
- 3. For a faculty member that accepts more than 1 new doctoral student (direct advancement, direct entry, and in-service doctoral students not included), his/her excess number of students accepted shall be deducted from their number of supervising students of the next or following academic year(s), and so forth.
- 4. For professors that voluntarily forfeit their supervision number of doctoral students, this number shall not be carried over and added to the following year.
- 5. Postgraduate supervisors must be full-time professors of the department.
- 6. The present regulations shall be implemented following the approvals of department general meetings and reviews and approvals of the College of Engineering heads meetings. The same procedure shall be carried out when amendments are to be made.
