NSYSU Regulations for Representative Sporting Team Housing Inquiries

- Article 1 These regulations (hereinafter referred to as the Regulations) are devised to facilitate engagement in sports and to reward outstanding performances of representative sporting members (including general students) who wins honor for the University (for Taiwan).
- Article 2 Representative sporting team members or other teams with the following qualifications may apply for the dormitory without entering the random draw:
 - 1. Winners of the Guo Guang Athletic Medal or the Chung-Cheng Sports Medal Reward shall be guaranteed housing without entering the random draw (for four years at most).
 - 2. Winners in the top eight of National Games or in the top four of National Intercollegiate Athletic Games, single sport tournaments, or the Top Group of Intercollegiate Leagues/Tournaments shall be guaranteed housing without entering the random draw in the next academic year (for two years at most).
 - 3. Winners in the top five to eight of National Intercollegiate Athletic Games, single sport tournaments, or the Top Group of Intercollegiate Leagues/Tournaments, or winners in the top three of the general division shall be guaranteed housing without entering the random draw in the next academic year (for one year at most).
 - 4. For team events, the guaranteed housing shall be rewarded to the number of members in the starting lineup (e.g. 5 members for basketball). Should there be changes of members in the game, the coach shall recommend the roster for the reward.
 - 5. Students with reward guaranteed housing should be members of the representative team, and should abide by the NSYSU Student Dormitory Management Regulations.
 - 6. Unauthorized transfer of bed spaces to others is not allowed; violators shall be evicted from the dormitory.
 - 7. The Sport Development Division shall tally the total number of eligible students according to the Regulations and propose the roster before the end of February.
- Article 3 Dormitory application and fee waiver for representative sporting team summer and winter trainings:
 - 1. Application: The dormitory application for winter trainings shall be submitted before January 10th; for summer trainings, the application shall be submitted before June 10th. The representative sporting team should submit supporting documents including the time of training, roster of members, content of training, waiver support form to the tam coach for authorization and send the submission to the Sport Development Division for further administrative processing.
 - 2. Rules of fee waiver:
 - (1) Teams with outstanding performance in the National Intercollegiate Athletic Games or in Intercollegiate Sports Tournaments of the previous year may apply for dormitory fee waiver for summer and winter trainings, the standards are as follows:

- a) The teams in the Elite Division of the National Intercollegiate Athletic Games or in Intercollegiate Sports Tournaments may have all fees waived.
- b) The teams in the top four of the National Intercollegiate Athletic Games or in Intercollegiate Sports Tournaments may have all fees waived.
- c) Teams which entered the finals of the National Intercollegiate Athletic Games or in Intercollegiate Sports Tournaments and did not reach the top four shall have 50% of the fees waived.
- (2) Teams without the aforementioned qualifications shall pay summer/winter dormitory fees in accordance to relevant regulations devised by the Campus Housing Service Division.
- Article 4 The Regulations should be implemented after being discussed by the Student Affairs Division Meeting, passed by the Dormitory Management Execution Committee Meeting, and approved by the NSYSU President. The same procedure applies in cases of amendments.
