### 第一條 宗旨

#### I. Objective

為表彰對學術研究有崇高成就或對人類生活有重大貢獻者，由本校頒授名譽博士學位。

The honorary doctorate shall be conferred by the University to persons with iconic academic research achievement or substantial contribution to the well-being of humanity.

### 第二條 依據

#### II. Legal basis

學位授予法第 15 條規定訂定之。

These regulations are formulated in accordance with Article 15 of *Degree Conferral Act*.

### 第三條 頒授資格

#### III. Qualifications for conferral

本國或外國人具有下列條件之一者，得由本校審查通過後，頒授名譽博士學位。

An honorary doctorate shall be conferred on domestic or foreign nationals who meet one of the following conditions after passing a conferral review by the University:

一、 在學術或專業上有特殊成就或貢獻，有益人類福祉者。

1. those who have iconic achievement or contribution in academia or other professions that is beneficial to human well-being;

二、 對文化、學術交流或世界和平有重大貢獻者。

2. those who make substantial contribution to cultural or academic exchange, or to global peace;

三、 對本校有特別重大貢獻者。

3. those who make substantial and significant contribution to the University.

第四條 頒授種類

IV. Area of conferred degree

以本校現有頒授之博士學位為範圍。

Honorary doctorates shall be conferred from the existing disciplines of the University.

第五條 審查

V. Conferral review

本項學位之審查經組成審查委員會辦理之，並由教務處承辦業務。

The conferral review shall be handled by a review committee, with the Office of Academic Affairs taking charge of relevant administrative works.

審查委員會由校長擔任主席，並聘請副校長、教務長、研發長、各學院院長、西灣學院院長、相關系（所、學位學程）主管、校內外講座教授及教授（含研究員）代表 6 至 8 人組成之。講座教授及教授代表由校長聘任之。

The President shall serve as the chairperson of the said committee. The committee members include one of the senior vice presidents, the vice president for Academic Affairs, the vice president for Research & Development, deans of individual colleges, the chair of the relevant department/institute/degree program, and six to eight chair professors or professors (including research fellows) from or outside the University appointed by the President.

審查委員會會議須有全體委員三分之二以上出席始可開會審議，審查委員不得委任他人代理；投票採無記名方式，並經全體委員二分之一以上贊成者始得通過。

The review committee shall be attended by at least two-thirds of all members before deliberation, and the committee members shall not appoint any proxy to attend on their behalf. Voting by secret ballot shall be conducted, with the consent of more than half of the attending members as passing the review.

第六條 名譽博士學位頒授後，本校應將推薦書（如附件格式）、審查會議紀錄及接受名譽博士學位者相關資料妥存備查。

VI. The recommendation letter (the format of which in the attachment), minutes of the review committee meeting, and the recipient's information shall be kept for reference after the conferment of honorary

doctorate.

第七條 名譽博士學位之服制、證書格式及授予儀式另訂之。

VII. The regalia, diploma format, and ceremony of conferral shall be formulated separately.

第八條 本辦法經本校教務會議通過，送請校長公告後實施，修正時亦同。

VIII. These regulations are approved by the Academic Affairs Council, and submitted to the President for approval before implementation. Amendment to these regulations shall follow the same procedure.
