# 國立中山大學 國際經營管理全英語學士學位學程相關規定 【113 學年度起入學新生適用】

Rules and Regulations for International Business Bachelor Program, NSYSU

[For students enrolled in (after) academic year 2024]

## 一、畢業學分 Graduation Credits

國際經營管理全英語學士學位學程最低畢業學分為128學分,包含通識教育與博雅課程(28學分;不含運動與健康4學分)、必修(38學分)及選修(62學分)。

Graduation from International Business Bachelor Program requires a minimum of 128 credits including General Education courses and Liberal Arts courses(28 credits, excluded 4 credits Sport&Health courses), compulsory courses(38 credits) and elective courses(62 credits).

## 三、選修學分 Elective Courses

(一)、選修學分無外系/院學分上限之規定,原則採計英語授課及第二外語教學課程之選修課,至多採計30學分之中文授課選修課。

Credits taken from other department/college as graduation elective credits are unlimited. However, only courses taught in English or a second foreign language are adopted as elective courses. At most, 30 credits are adopted for elective courses taught in Chinese.

(二)、112 學年起凡本學程學生均須選修國立中山大學管理學院開設之英語授課「國際商管倫理觀的理論與實務」課程方得畢業。

Starting from Academic Year 2023, all IBBA students must select the course "The Theory and Practice of Ethics in International Business Management" as part of the graduation requirements.

## 四、出國進修 Studying Abroad

國際經營管理全英語學士學位本國籍生於畢業前,須至海外交換至少一學年,修習非中文授課學士級(含)以上課程,返校後申請抵免本校至少18~24學分(或6門課);並依教務處公告「交換校學分轉換暨成績轉換參考表」作為對照標準。

As part of the domestic student (Taiwanese) graduation requirements, it is required

to join the International Exchange Program for at least one year. While studying abroad, students must select at least  $18^2$ 4 credits (or 6 courses) of non-Chinese teaching courses at the Bachelor level or higher. It is mandatory to pass all the subjects in the partner universities. Credits taken in the partner universities can be waived upon return to school under the regulation 交換校學分轉換暨成績轉換參考表 from Office of Academic Affairs.

#### 五、國際或跨域學習 International or Interdisciplinary Learning

依本校「第162次教務會議」規定,109學年度起入學學士班學生,應符合下列至少一項「國際或跨域學習」畢業條件:

- 1. 國際學習:出國交換或研修至少一學期或完成所屬學系審查同意之國外研修課程至少 2學分或國外研修計畫(學習時數至少36小時)。
- 2. 跨域學習:取得本校或他校一個<u>輔系、雙主修或教育學程</u>或本校開設之<u>微學程</u>(課程或師資需具備跨院合作性質)、整合學程(含個人化學程)或跨系所專業學程。

According to resolution from the 162th Administrative Meeting: undergraduate students enrolled in Academic Year 2020 and after shall meet one of the following "international or interdisciplinary learning" as graduation requirement.

- 1. International learning: at least one semester of exchange or training abroad, or at least 2 credits from foreign study courses or foreign study programs (at least 36 hours) approved by the department.
- 2. Interdisciplinary learning: earn <u>a minor or double major</u>, or <u>education program</u> from the University or other school, or apply for <u>micro-study programs</u>, <u>integrated programs</u>, or department(institute) professional programs.
