- 一、本要點依據國立中山大學教師評審委員會設置辦法之規定訂定之。
 - I. The present guidelines have been established by the College of Marine Sciences (hereafter referred to as "the College") in accordance with "National Sun Yat-sen University Regulations for Faculty Evaluation Committees".
- 二、各系、所擬聘專、兼任教授、副教授、助理教授及講師,需符合「國立中 山大學教師及研究人員聘任規則」及其他相關之規定辦理。
 - II. All departments and institutes must handle the appointment of full-time and adjunct professors, associate professors, assistant professors, and lecturers in accordance with the "Regulations for Appointment Qualifications of Faculty and Researchers at National Sun Yat-sen University" and other relevant regulations.
- 三、新聘教師辦理外審所提之專門著作(含學位論文)、成就證明或技術報告件 數至多十件。教師應自行擇一為代表作,屬系列相關研究著作(作品)得合 併為代表作,其餘列為參考作。
- III. The employment of new faculty member shall submit up to ten specialized publications (including degree thesis), distinguished achievements or technical reports for the external review. Faculty shall choose one as the representative publication, and the related publications (works) in the series can be combined into the representative publication, and the rest are listed as reference publications.
- 四、各級兼任教師之聘任,依「國立中山大學兼任教師聘任資格審查要點」之規定辦理。
- IV. The eligibility and review for the appointment of adjunct faculty members at various institutional levels shall be handled in accordance with "Guidelines for Adjunct Faculty Appointment Qualifications at National Sun Yat-sen University".
- 五、有關教師之聘期、停聘、解聘及不續聘等事項,悉依本校相關規定辦理。
 - V. The appointment period, suspension, dismissal, and non-renewal shall be handled in accordance with relevant university regulations.

Any dispute over interpretations of these regulations shall be resolved in the court of law based on the Chinese version.

- 六、本要點經院務會議、校教師評審委員會審議通過,陳請校長核定後實施, 修正時亦同。
- VI. The present guidelines shall be implemented following approvals of College General Meetings and the University Faculty Evaluation Committee, as well as authorization of the president. The same procedure shall be carried out when amendments are to be made.
