Article 1. Purpose

To encourage academic research and academic activities of the College of Management of National Sun Yat-sen University.

Article 2. Conference and Seminar Funding

The College will grant the conference and seminar funding to faculty who has applied and received subsidy for holding academic conference or seminar according to one of the following two restrictions:

1. Applicant must apply to the University's Office of Research and Development in accordance with the "National Sun Yat-sen University Guidelines for Academic Activity Subsidies"
2. Applicant must apply to the National Science and Technology Council (NSTC) in accordance with the "Instructions for Funding of the Holding of International Academic Conferences in Taiwan", the "Guidelines for Cross-Strait Technological Research Seminar Subsidies", the "Guidelines for National Academic Institute Hosting Academic Events", and in accordance with the "Guidelines for Domestic Academic Seminar Subsidies"

The faculty is required to also enclose the event proposal (including the budget table) to the College. The College will fund for event expenses based on the higher grant between 1. and 2. The maximum amount of subsidy will be NT\$300,000.

Electronic copies of the research paper(s) presented at the academic conference or seminar should be enclosed to the College after the event.

Article 3. Research Team Funding

To enhance the College's competitiveness in academia, the College will fund a research team formed by two or more full-time faculty and contract members from the College for the use of hiring temporary worker(s) or business expense(s) per faculty per year upon review and approval

of the application. The application must enclose a project proposal and a statement of the proposed project is not any research team member's NSTC -granted research project. Upon application review and approval, a subsidy of NT\$ 100,000 for the purpose of hiring temporary worker(s) or business expense per year per interdepartmental faculty; or a subsidy of NT\$ 80,000 for the purpose of hiring temporary worker(s) or business expense per year per faculty. The maximum amount of subsidy per research team is NT\$ 200,000. The funded research team is required to attend academic sharing session to share the research results. Each faculty is limited to two projects per calendar year. Eligibility criteria include:

1. Preference is given to research teams organized in mentor/mentee combinations.
2. Applicants must submit tangible research results from prior funded team projects as a basis for personal application qualifications. Multiple submissions of the same research paper will not be considered.
3. Funded research teams must present at a conference within two years of the approval semester or publish at least one international journal article (SSCI, SCIE, or TSSCI journals) within four years.

Article 4. International Top-Tier Journal Proofreading or Translation Funding

This funding is limited to paper conducted in English published in top-tier international journals (see Attachment 1). Each faculty will be granted a maximum of NT\$40,000 per year (but not limited to paper that received first revise and resubmit). The paper must be published in the name of National Sun Yat-sen University. The funding is limited to the first author or the corresponding author (proof required). Also, if there are more than two institutes in the affiliation of the paper published by the University's faculty, it is limited to National Sun Yat-sen University as the first institute.

Article 5. International Collaboration

To encourage the collaboration with international institute(s), expert(s), or scholar(s), faculty who has not been granted Research Distinguished Reward in the semester but met all of the following conditions is eligible for a subsidy for business expense of NT\$ 30,000 per research article:

1. As a first author or corresponding author to publish a research paper on an SSCI or SCI / SCIE top 30% Impact Factor journals, and listing National Sun Yat-sen University as the affiliation Academic papers published in publishers subject to enhanced substantive review, predatory journals, and mega journals listed by our university's Office of Research and Development will not be counted.
2. At least one of the co-authors must be an expert or scholar from an international institution or university
3. The address of the University faculty, if more than two affiliations, listing National Sun Yatsen University as the first affiliation address

Each faculty can be granted up to two articles per calendar year. The faculty receiving the subsidy is required to attend academic sharing session to present the research.

Article 6. Funding and Proofing Documents

This Guidelines funding is supported by the Executive Master of Business Administration (EMBA) program funding. Faculty who apply according to Article 2 shall enclose funding letter, application, and support documents; Faculty who apply according to Article 3 shall enclose project proposal to the College office after the application announcement in each semester, the funding will be granted upon approval by Directors' Council; Faculty who apply according to Article 4 shall enclose the English paper after it is proofread or translated, original receipt, and proof of paper submission (if the proof is given at the end of the year, applicant may apply for the funding first, and submit the proof at a later date. Please note that the College will not consider any proof that is not for the current year) and apply following the Dean's office announcement in December.

Article 7. Guidelines and Amendments

This guidelines, as well as its amendments, are effective upon approval by the College Council Meeting and the University President.

一、(宗旨)

國立中山大學管理學院（以下簡稱本院）為鼓勵學術研究暨學術交流活動之舉辦，特訂定本要點。

二、（學術研討會之補助）學術研討會之補助，須依本校「學術活動補助要點」向本校研究發展處提出申請，或向

國家科學及技術委員會（以下簡稱國科會）依「補助國內舉辦國際學術研討會作業要點」、「補助兩岸科技學術研討會作業要點」、「全國性學術團體辦理學術推廣業務計畫」補助學術研討會及依「補助國內學術研討會作業要點」等申請學術研討會補助，並獲得舉辦學術會議補助者，檢附活動計畫書（含經費預算表），本院再以上列較高補助金額之額度給予業務費補助，但補助上限為新台幣 30 萬元。

學術研討會活動結束後應檢附論文集電子檔案送院存查。

三、（籌組研究團隊補助）為增強本院學術研究競爭力，鼓勵本院教師共同研究，凡由本院二位以上編制內專任教

師組成研究團隊，得檢附計畫構想書，並聲明擬執行計畫非為團隊成員執行國科會計畫，經審查通過，為跨系所者每年每位可獲補助工讀金或業務費新台幣(以下略)10 萬元，非跨系所者為每人每年 8 萬元，且每研究團隊獲補助工讀金或業務費上限為 20 萬元。獲補助之研究團隊需配合出席學術分享會，說明研究成果。但每位老師每日曆年以補助 2 件計畫為限。

四、（頂尖期刊論文編修或譯稿補助）本校專任教師為將研究成果以英文發表於附件 1 所列之頂尖期刊。

本要點補助每人每年補助上限 4 萬元，但通過第一次編修之論文，不受 4 萬元之限制。申請論文須為以國立中山大學之名義發表投稿之期刊，且補助第一作者或通訊作者（請附證明）為限，另本校教

師所發表論文地址欄，如有兩個以上單位時，以中山大學為第一單位之名義發表者為限。

五、（鼓勵國際合作）為鼓勵與國外機構專家學者合作，如當學年未獲研究績優獎勵，符合以下條件者，每篇給予 3 萬元業務費補助：

1. 以國立中山大學之名義公開發表之論文屬 SSCI 或 SCI / SCIE 收錄 Impact Factor 前 30% 期刊，並為第一作者或通訊作者。
2. 合著人至少一人須為國外大學或機構之專家學者。
3. 本校教師所發表論文地址欄，如有兩個以上單位時，以中山大學為第一單位之名義發表者為限。

每位老師每日曆年以補助 2 篇為限。獲補助之教師需配合出席學術分享會說明研究成果。

六、（經費來源、檢附文書）本要點補助款經費來源為本院之在職專班結餘款。

依第二點提出申請者，應檢附當年度獲補助通知函、申請表及相關文件；依第三點提出申請者，應檢附計畫構想書，配合每學期初公告期間向法院辦公室提出申請，經主管會議審議後核給；依第四點提出申請者，須檢附編修或翻譯後之英文論文、當年度原始憑證（收據或發票）、論文投稿證明（如憑證為當年度末，因尚未即時投稿者，得先申請本補助，再補投稿證明），配合每年 12 月公告期間提出申請，憑證非為當年度者不予受理。

七、（實施與修正）

本要點經院務會議通過後，陳請校長核定後實施，修正時亦同。
