Guidelines on the Establishment of the Dormitory Management Committee

- 一、 為強化學生宿舍管理,提供學生優良住宿環境,依本校組織規程第四十六條規定,設置學生宿舍管理委員會(以下簡稱本會)。
- I. The NSYSU Dormitory Management Committee (hereinafter referred to as the Committee) is established in accordance with Article 46 of *NSYSU Charter*, to strengthen student dormitory management and provide fine accommodation to students.
- 二、 本會組織成員如下:
- II. The members of the Committee shall comprise:
 - (一) 主任委員:副校長。
 - (1) Chairperson: Senior Vice President;
 - (二) 副主任委員:學生事務長。
 - (2) Deputy Chair: Vice President for Student Affairs;
 - (三) 委員:主任秘書、總務長、國際長、主計室主任、副學生事務長、學 生宿舍自治委員會主任委員、學生會代表1人。
 - (3) Members: Chief Secretary, Vice President for General Affairs, Vice President for International Affairs, Chief of Accounting, Associate Vice President for Student Affairs, President of the Dormitory Management Execution Committee, one representative of the NSYSU Student Association;
 - (四) 執行秘書:宿舍服務組組長兼任。
 - (4) Executive Secretary: concurrently assumed by the Director of the Campus Housing Service Division.

Any dispute over interpretations of these regulations shall be resolved in the court of law based on the Chinese version.

- (五) 必要時得邀請營繕組組長、資產經營管理組組長、校園生活與職涯發展組組長與相關業務單位代表列席參加
- (5) The Committee may invite the Director of the Construction & Maintenance Division, the Director of the Property Management Division, the Director of Student Life and Career Development Division or other representatives from relevant units to attend the meeting when necessary.

三、 本會職掌如下:

- III. The functions of the Committee shall be as follows:
 - (一) 學生宿舍預算編列之研議。
 - (1) Discussing the budgets of student dormitories.
 - (二) 學生宿舍管理相關事項之研議。
 - (2) Discussing relevant issues of student dormitory management.
- 四、 本會每學期召開會議一次,必要時得召開臨時會議。
- IV. The Committee shall convene at least one meeting per semester. Interim meetings may be convened when necessary.
- 五、 本要點經行政會議通過,陳請校長核定後實施,修正時亦同。
- V. The Guidelines should be practiced after being passed by the Executive Meeting and approved by NSYSU President. The same procedure applies for future amendments.
