

Guidelines for Internet Network in Student Dormitories

Approved at the 2nd Executive Meeting on September 29, Fall semester 2010

Approved at the 7th Executive Meeting on November 20, Fall semester 2024

- I. This set of guidelines is specifically issued for sufficient utilization of on-campus Internet functions, implementation of appropriate use of Internet resources, and efficient management of student dormitory Internet network. The regulations are in accordance with "Regulations for Internet Network Use on Campus " of the university.
- II. All student residents who want to use dormitory Internet shall prepare a personal computer, network card (RJ-45 interface), and UTPs (Unshielded Twisted Pair). The use of Internet resources shall be in accordance with the IP addresses allocated by the Office of Library and Information Services.
- III. In cases of any of the following conditions being investigated and evidenced, not only the penalties of relevant regulations will be carried out but also suspensions of rights to access will be implemented.
 1. Transmitting threatening, indecent, commercial, or unfriendly data.
 2. Spreading viruses or intruding unauthorized computer systems.
 3. Any misuse of network resources, such as mass-sending spam or similar information, or any other behavior that adversely affects the normal operation of the dormitory network system.
 4. Using or transmitting any unauthorized files.
 5. Intentionally damaging or inadequately using network equipment.
 6. Using methods such as email, online chats, electronic bulletin boards, or other similar functions to disseminate information that spreads rumors, commits fraud, defames, insults, obscene, harasses, threatens, or otherwise violates social morals.
 7. Without authorization, interfering with another person's computer system or related equipment by means of computer programs or other electronic devices.

Applications for resumes of rights to access are available after suspensions due to above reasons have been removed.

- IV. In order to promote the rational use of network resources, the management Any dispute over interpretations of these regulations shall be resolved in the court of law based on the Chinese version.

unit reserves the right to implement network traffic management measures as stipulated in the policies of the Ministry of Education or this institution. These measures will be publicly announced on the Library and Information Services Department website. It is strictly forbidden to use computer programs or other electronic means to illegally interfere with another person's computer system. Violators will be subject to relevant legal consequences.

- V. Failures of student dormitory Internet networks can be reported, and maintenance will be applied by visiting the website of the Office of Library and Information Services for "Sun Yat-Sen University Dormitory Network Repair System." The duty personnel will respond to requests of maintenance as soon as possible after receiving repair application forms.
- VI. Management and operation of student dormitory Internet network is governed by the Office of Library and Information Services of the university.
- VII. For inadequate and unmentioned matters of this set of regulations, please refer to Ministry of Education Regulations for On-Campus Internet Network Use, Taiwan Academic Network Management and Regulations, and regulations of the university.
- VIII. These guidelines have been approved by the Executive Meeting and submitted to the University President for approval and implementation. Amendments to these regulations shall follow the same procedure.
