- 一、 為有效推動本校校園學生自我傷害三級預防工作及減少校園自我傷害事件之發生,特訂定本要點。
- I. These guidelines are formulated to effectively implement three-level preventive measures against student self-inflicted injury on campus to reduce such incidents.
- 二、 實施目標:
- II. Implementation Goals:
 - (一)完成編定全校性自我傷害三級預防工作計畫、建立並落實學生自 我傷害三級預防工作模式,以及建立自我傷害之危機處理標準作 業流程,以減少校園自我傷害事件之發生。
 - (1) completing a University plan of three-level preventive measures against self-inflicted injury, establishing and realizing a work model for the plan, and developing crisis management standard operating procedures, to minimize the occurrence of such incidents
 - (二)發展與推動增進學生尊重生命、關懷生命、珍愛生命、展現正向 積極生命意義、增加心理健康識能、因應壓力與危機管理,及對 於自我傷害危機學生的賦能技巧之教學與活動,並提升校園內支 持系統與環境安全。
 - (2) developing and promoting the education and activities which teach students to respect, care for, and appreciate life, to manifest positive meanings of life, to raise awareness of mental health, to cope with stress, and to manage crisis, as well as to enhance supporting systems and environmental safety on campus
- 三、 防治執行工作分初級預防、二級預防及三級預防
- III. The task of preventive measures shall be divided into three levels.

(一) 初級預防:

- (1) Level 1 Preventive Measures:
 - 1. 配合教育部定期督導本校自我傷害三級預防工作。
 - i. cooperating with the regular supervision on the task by the Ministry of Education (MOE)
 - 2. 整合本校資源,強化各處室合作機制。
 - ii. integrating available resources on campus and strengthening the coordination between offices
 - 3. 建立校園危機應變機制,設立24小時校安通報求助專線,訂定 自我傷害事件危機應變處理作業流程,並定期進行校安通報、 自殺防治通報及身亡事件處理流程演練,宣導學生可利用相關 資源。
 - iii. establishing a campus crisis response mechanism, setting up a 24-hour campus safety hotline, formulating an operational procedure of such crisis response, regularly practicing drills on safety reporting, suicide prevention reporting, and the procedure for handling death, as well as disseminating relevant resources to students
 - 4. 鼓勵教師將多元智能和價值、心理健康促進和維護、壓力因應、提升問題解決力、挫折容忍力、負向思考和情緒之覺察、接納及調控策略、網路成癮與網路霸凌等網路不當使用、常見精神疾病與求助資源、憂鬱與自我傷害之危機處理、自助與助人技巧等相關議題納入課程計畫、融入教學課程及體驗活動。
 - iv. encouraging faculty to include the following topics into their curriculum design, lesson planning and learning activities: multiple intelligences and values, mental health promotion and maintenance, stress management, problem solving skills, frustration tolerance, awareness of negative thinking and emotion and the acceptance and adjustment strategies thereof, improper internet use (including internet addiction and cyberbullying), common mental illness with available resources for help, crisis management for depression and self-inflicted injury, and self-help and helping skills
 - 5. 強化學校人員(導師、校安人員、專業輔導人員、校警等)熟 悉校園事件處理流程對自我傷害辨識及危機處理知能。
 - v. strengthening the university personnel's (mentors, campus security officers, professional counselors, campus security guards, etc.) familiarity with the handling procedure of campus incidents, identification of self-inflicted injury, and crisis management skills
 - 6. 結合社團及社會資源辦理生命教育與自我傷害防治活動,強化

學生成為自殺防治生命守門人,增加自我傷害危機辨識與處理及自我賦能、網路成癮及網路霸凌等網路不當使用議題之防治知能和學生求助資源運用。

- vi. integrating student clubs with community resources to organize life education and self-inflicted injury prevention activities, such as strengthening students to become gatekeepers for suicide prevention, enhancing students' self-inflicted injury crisis identification and handling skills, improving their abilities in self-empowerment, preventing issues regarding improper internet use (such as internet addiction and cyberbullying), and utilizing help resources
 - 7. 建置專屬網頁,整合自我傷害及危機處理有關的資源提供線上搜 尋及運用。
- vii. establishing a dedicated webpage for easy access to information integrating self-inflicted injury prevention with crisis response
 - 8. 進行建物防墜安全檢查,針對校園建物(如高樓之頂樓、中庭,及樓梯間),設置預防性安全設施(安全網、監視及警報系統設置)、生命教育文宣及求助專線之宣導資訊。
- viii. conducting safety inspection on campus buildings (such as the top floor of high-rise buildings, atrium, and stairways), installing preventive safety devices (safety nets, surveillance systems, and alarm systems), and disseminating information about life education and helpline contacts
 - 9. 建立友善的校園氛圍,提供教職員工正向積極的工作態度訓練
 - ix. creating a friendly campus atmosphere and providing faculty and staff with trainings on maintaining a positive work attitude

(二) 二級預防:

- (2) Level 2 Preventive Measures:
 - 利用電腦管理系統建立學生輔導資料庫,隨時掌握輔導動態,統計分析之資料提供政策與工作方針之參考。
 - i. establishing a student counseling database to consistently monitor counselling information and utilizing data from statistical analysis as a reference for policy making and work guidelines
 - 實施每年度全校性新生心理測驗篩檢高關懷學生,並與導師合作,共同照護新生篩檢之高關懷學生,必要時轉介輔導。
 - ii. conducting annual university psychological assessment of new students to identify those requiring close attention, collaborating with mentors to provide the said students with care, and arranging referral

to counselling when necessary

- 3. 針對特殊狀態或心理發展特殊需求學生提供主動關懷。
- iii. proactively providing care to students with special situations or specific requirements based on their psychological development
 - 4. 提升導師、校安人員、同儕、教職員工、家長之憂鬱與自殺風險 度之辨識與危機處理能力,對所發現之高關懷學生提供進一步個 別或團體諮商輔導。
- iv. enhancing the abilities of mentors, campus security officers, student peers, faculty, staff, and parents in identifying and handling depression and suicide risk and providing the identified students with advanced individual or group consulting services
 - 5. 整合校外專業人力(如:精神科醫師、臨床心理師、諮商心理師、社工師等)到校服務。
- v. integrating external professionals (such as psychiatrists, clinical psychologists, counseling psychologists, social workers, etc.) into oncampus services

(三) 三級預防:

- (3) Level 3 Preventive Measures:
 - 1. 建立「國立中山大學學生自我傷害防治處理機制流程」。
 - i. establishing the "Student Self-Inflicted Injury Handling Procedures"

 - ii. conducting reporting, on-site handling, tracking, and counselling services in accordance with the "Crisis Management Procedures for Mental Illness and Self-Inflicted Injury Cases" in the event of self-inflicted injury incidents
 - 3. 安排自殺企圖者進行心理諮商與治療預防再次自殺;與家長聯繫提供說明、情緒支持與預防再自殺教育;提供受到影響的個人或群體心理衛生教育及團體輔導。
 - iii. arranging psychological counselling and treatment for those attempting suicide to prevent the second attempt, contacting their parents with explanations, emotional support, and education on suicide prevention, and providing mental health education and group counselling for affected individuals and parties
 - 4. 自殺身亡事件依「國立中山大學學生自殺或意外死亡處理處理流程」進行個案處理,含說明(校內外公開說明、媒體等)、家屬聯繫、教育輔導與各層級哀傷輔導、機會教育降低自殺模仿效

- iv. managing suicide cases in accordance with the "Student Suicide or Accidental Death Handling Procedures," which involves explanations (through internal and external public announcement and media), contacting the family, offering educational counselling and grief counselling at individual levels, and implementing a prevention and awareness campaign through such incidents in order to mitigate the risk of suicide imitation

- v. reporting and making referral depending on the nature of the self-inflicted injury incidents in accordance with MOE's *Guidelines on Reporting of Campus Safety and Disastrous Events* and the "Suicide Prevention and Referral Procedures" from the Ministry of Health and Welfare
- 6. 持續對受到自傷事件影響的個人、團體、教師同仁、家屬等提供協助,必要時亦針對專業遺族 (如輔導老師與專業輔導人員)提供 心理諮商與治療。
- vi. consistently providing assistance to individuals, groups, faculty, family members affected by the self-inflicted injury incidents and offering counselling services or treatments to professionals (such as mentors or professional counselors) when necessary
- 7. 建立學校和區域醫療衛生網絡、自我傷害防治資源的雙向聯繫、 銜接,及共照機制,提供個案學習不中斷之資源連結,亦建立學 校與當地社政單位、勞政單位之雙向聯繫。
- vii. establishing a bilateral contact, connection, collaborative mechanism between the University and local healthcare networks as well as self-inflicted injury prevention resources, to ensure the continuity of resource sharing and establishing bilateral communication between the University and local social and labor authorities
 - 8. 本校各級防治執行工作之權責單位與分工如附表。
- viii. Details of the individual units responsible for tasks of preventive measures at different levels are stipulated in the Appendix.
