- 一、為審議本系專、兼任教師之聘任，依據本校教師評審委員會設置辦法、教師及研究人員聘任規則及理學院教師聘任要點，訂定本要點以憑辦理。
 - I. These guidelines are formulated to review the appointment of full-time and adjunct faculty in the Department of Chemistry (hereinafter referred to as the “Department”) in accordance with the University’s *Regulations for the Establishment of Faculty Evaluation Committees, Regulations for the Appointment of Faculty and Researchers, and Guidelines on the Appointment of Faculty in the College of Science*.
- 二、本系擬聘專、兼任教授、副教授、助理教授，需符合本校教師及研究人員聘任規則，並經由本系教師評審委員會初審通過，再送理學院教師評審委員會複審。
 - II. Applicants for a full-time or adjunct faculty position as a professor, associate professor, or assistant professor in the Department shall meet the requirements stipulated in the *University’s Regulations for the Appointment of Faculty and Researchers*. Their appointments shall be reviewed by the Department Faculty Evaluation Committee (DFEC) subsequently before being forwarded to College Faculty Evaluation Committee (CFEC) for official approval.
- 三、本系擬聘專、兼任教授、副教授及助理教授，除符合第四點者外，均需辦

理著作外審。新聘專、兼任助理教授由院將其學術著作送外審，以供本系教師評審委員會審議時參考。新聘專、兼任副教授以上之教師，由校教師評審委員會辦理著作外審。

- III. The Department seeking to appoint a full-time or adjunct assistant professor or higher ranks shall organize an external review on applicants' academic works, except for those who meet the requirements stipulated in Article 4. The College of Science (hereinafter referred to as the "College") shall organize an external review for the appointments of new (full-time or adjunct) assistant professors, with the results of external reviews being submitted to the CFEC for deliberation. The University Faculty Evaluation Committee (UFEC) shall organize an external review for the appointment of new associate professors or professors.

前項外審著作或技術報告至多十件；擬受聘者應自行擇一為代表作，其餘列為參考作，其屬系列之相關研究者，得合併為代表作。

The applicants may submit up to ten academic publications or technical reports for the external review, and shall select one representative work and use the rest as reference. Related works constituting a series may be compiled into one representative work.

- 四、本系擬聘之各級專、兼任教師，若符合本校相關聘任免外審規定，且經系教師評審委員會全體委員三分之二以上出席並經出席委員三分之二以上審查同意者，得免辦理著作外審。

Applicants for full-time or adjunct faculty positions at all ranks in the Department who meet the University's criteria may proceed without external review, provided that the DFEC, with at least two-thirds of all members in attendance, with the approval of two-thirds of the members present.

- 五、其他聘任(合聘等)案件需經本系教師評審委員會會議通過後送理學院教師評審委員會審查。

- IV. Other appointments (such as joint appointments) shall be submitted to the DFEC and the CFEC for approval.

- 六、新聘教師審查案件，出席及通過人數之門檻，依本校教師評審委員會設置辦法規定辦理。

- V. The quorum and voting threshold of a meeting to review the appointments of new faculty shall comply with the University's *Regulations for the Establishment of Faculty Evaluation Committees*.

- 七、有關教師之聘期、停聘、解聘、不續聘及基本授課時數等相關事項，悉依本校相關規定辦理。

- VI. Matters regarding term, suspension, dismissal, or non-renewal of appointment, as well as teaching hours, shall be handled in accordance with the University's relevant regulations.
- 八、本要點經本系教師評審委員會、系務會議通過，送理學院教師評審委員會審議通過，陳請校長核定後實施，修正時亦同。
- VII. These guidelines are approved by the DFEC, Department Council, CFEC, and the President before implementation. Amendments to these guidelines shall follow the same procedure.
