一、本要點依據國立中山大學延攬及留住特殊優秀人才實施規範第五章第二節第一目訂定。

I. These guidelines are formulated in accordance with Item 1, Section 2 of Chapter 5 in the University's *Regulations for the Implementation of Recruitment and Retention of Outstanding Faculty*.

二、基本資格：本校任職滿一年以上之專任教師、約聘教師、約聘研究人員(不含博士後研究人員)，且符合下列規定之一者，得申請學術研究績優教師：

II. Basic qualifications: Faculty shall be eligible for the Prominent Faculty in academic research in the College of Marine Sciences (hereinafter referred to as the "College") if they are full-time faculty within and beyond the manning quota or contract-employed researchers (excluding postdoctoral research fellows), serve at the University for at least one year, and meet the following conditions:

(一) 須符合國立中山大學教師學術倫理實施方案之規定。

(1) fulfilling the requirements stipulated in University's *Faculty Academic Ethics Implementation Plan*

(二) 3年內擔任國科會年度專題研究計畫、國科會國際合作計畫(惟純國際差旅及參加國際會議屬性之計畫例外)主持人、教育部教學實踐研究計畫主持人或經全球產學營運及推廣處認定之產學合作計畫共3件(含)以上，且3年內所發表「科學引用文獻索引(Science Citation Index Expanded, SCIE)，以下簡稱SCIE」之論文篇數至少2篇或發表「社會科學引用文獻索引(Social Science Citation Index, SSCI)，以下簡稱SSCI」之論文篇數至少1篇。

- (2) being the principal investigator (PI) of at least three projects/programs within the past three years, including general projects funded by the National Science and Technology Council (NSTC), NSTC International Cooperation Programs (excluding those solely for international travel or participation in international conferences) and the Ministry of Education (MOE) Teaching Practice Programs, or conducting at least three industry-academia collaboration projects recognized by the Office of Global Industry-Academe Collaboration and Advancement, and publishing at least two papers in “Science Citation Index Expanded (SCIE)” journals or at least one paper in “Social Science Citation Index (SSCI)” journals within the past three years.

(一) 國科會計畫、教育部教學實踐研究計畫之採計，以申請年度往前推三年，且以國科會計畫編號標示之年度為準。例如 105 年 4 月申請，則採計 MOST102-XXXX-X-XXX-XX、MOST103-XXXX-X-XXX-XX 及 MOST104--XXXX-X-XXX-XX 三年的計畫；如為多年期計畫，則依計畫編號標示年度往後採計之，例如 105 年 4 月申請，MOST102-XXXX-X-XXX-XX-MY3 採計 3 件計畫，MOST103-XXXX-X-XXX-XX-MY3 則採計 2 件計畫，其餘類推。

(1) For NSTC research projects and MOE Teaching Practice Programs, those within three years prior to the award application shall be counted, according to the year indicated in the project number. For instance, projects with the coding numbers of MOST102-XXXX-X-XXX-XX, MOST103-XXXX-X-XXX-XX, and MOST104-XXXX-X-XXX-XX shall be eligible for the application in April 2016. As to multi-year projects, a three-year project with the coding number of MOST102-XXXX-X-XXX-XX-MY3 or MOST103-XXXX-X-XXX-XX-MY3, 3 or 2 projects shall be counted respectively for the application in April 2016.

(二) 以上論文之採計，以申請截止日期往前推三年，例如 102 年 4 月申請，則採計 99 年 1 月 1 日至 101 年 12 月 31 日止，以正式出版日為準，

期刊排名以最新資料之最佳排名為依據。

- (2) The calculation methods for the papers mentioned above shall apply only to those published within three years prior to the application deadline. For example, if the deadline is in April 2013, only those with published dates between January 1, 2010 and December 31, 2012 shall be eligible. The journal ranking shall refer to the latest best JIF ranking.
- (三) 前述論文發表，須為學生以外之第一作者或論文通訊作者，且發表者以中山大學為第一單位之名義發表為限。計算 Impact factor 時，若第一作者或通訊作者有二人（含）以上，得分均分之，但以三篇為限；第一作者與通訊作者擇一計算。論文採認之爭議由研發處認定之。（註：依本院 105-07 次教評會決議：第一作者或通訊作者之 affiliation 是中山大學，論文均可計分。）
- (3) Papers shall be recognized if the applicant is the first author (not counting student) or the corresponding author, with the University as the first affiliation. If there is more than one first or corresponding author of a paper, the points given to the paper shall be divided equally by the number of the first or corresponding authors, with a maximum of three papers; individuals who are both the first author and the corresponding author shall choose one only. Any disputes over the recognition of a paper shall be resolved by the Office of Research and Development (ORD).
- (四) 凡任職於本院之專任教師，三年內以本校名義參與發表於 *Science*、*Nature* 期刊論文(不含系列論文、讀者投書)者，不受本要點第二、三、四點之限制，即優先排序，送研發處確認。
- (4) Full-time faculty within the manning quota shall be exempt from the restrictions stipulated in Articles 2 to 4, and given the priority on the list when they publish papers in *Science* or *Nature* journal (excluding series of papers and dissent to published papers) with the University as the affiliation within the past three years; such cases shall be submitted to the ORD for confirmation.
- (五) 申請教師應自行檢附相關佐證資料(如國科會計畫、教育部教學實踐研究計畫核定清單、著作第一頁封面、期刊排名等)供查核，未檢附者，不予採計。
- (5) Applicants shall attach relevant supporting documents for review (e.g., approval lists of NSTC projects or MOE Teaching Practice Programs, the first page of publications, and journal ranking). Those who fail to do so shall not be given the points.

四、審查作業程序：符合基本資格之教師，於每年依研發處公告時程填具「國立中山大學學術研究績優教師」海洋科學學院申請表（如附件），經系所教評會審核後，向海科院申請，並由海洋科學學院教師評審委員會將審查結果排序（以本院教師人數30%為限），送研發處確認。

IV. Review procedure: The faculty fulfilling the basic requirements may submit their Application Form for Prominent Faculty in Academic Research in the College of Marine Sciences (see the attachment) to the College after the approval from their department/institute/degree program faculty evaluation committee (DFEC), according to the annual timeline announced by the ORD. The College Faculty Evaluation Committee (CFEC) shall rank the applicants (no more than 30% of the faculty of the College) based on the review results and then submit the list of applicants to the ORD for confirmation.

五、本要點經海洋科學學院院務會議通過後施行，修正時亦同。

V. These guidelines are approved by the College Council before implementation. Amendments to these guidelines shall follow the same procedure.
